It will be the largest private sector investment in Circleville in decades and it started right here at SelectUSA"*

After entering the North-American market in 2012, the Group is currently committed to investing more than \$ 300 million over a three-year period. The most significant investment is right here in Circleville, Ohio, which President Obama referred to.
